Towards a Public Inquiry into White Collar Crime In Preparation of the Economic Crime Agency

The Coalition Programme of the Governmentⁱ asserts on page 9 that it wants to take white collar crime as seriously as any other, by setting up an *Economic Crime Agency*.

Our experiences are based on meetings at the House of Lords and Commons since 1998ⁱⁱ. They include research and many first-hand experiences by *victims of financial exploitation and legal oppression*ⁱⁱⁱ. Victims have been suffering from fraud, perjury, miscarriage of justice and abuse of process carried out by

Given that the *Bank of England Act 1694*^{xix} is not followed by the letter, we are advocating the *Government as Compensator of Last Resort*^{xx}.

Issues to be covered by a scoping document comprise:

- Problems are systemic and cover
 - The financial profession: banks and bankers
 - The legal profession: lawyers, judges and insolvency practitioners
 - The Judiciary system: HM Court Services, HM Prison, the Court of Protection
 - The medical profession: the General Medical Council
 - The accountancy profession: e.g. Ernest & Young, Deloittes
 - The Land Registry
 - Inland Revenue
 - Customs & Excise
- The difficulty of [Reporting of Fraud](#) [see EDM 516^{xxi}]
 - The [Memorandum of Understanding](#)^{xxii} between the *Association of Chief Police Officers* and the *Law Society*
 - The [Royal Charter](#) as the ticket to immunity from prosecution for some 1000 organisations with that status
 - Judges operate above the law [see www.JudgesAboveTheLaw.com and [Outlaw Judges](#)]
- The difficulty of obtaining legal representation
 - Litigants in Person (LIPs) are a challenge to the legal profession in the adversarial system
 - LIPs cannot get their money back if they paid for legal advice
 - Legal Aid as a ticket for the ‘gravy train’ but to provide justice
- The creation of “credit money” from thin air – the ultimate institutionalised white collar crime
 - The Bank of England and the Treasury with ‘treasury bonds’ as public debts
 - Investment Banks and other financial institutions.

It is hoped that a committee will be formed that is broad-minded enough to carry all of the issues further. For any system can only be changed not by patching up symptoms but by taking a holistic approach that tackles root causes and principal effects.
