There can be no lawful reason why "there is conflicting information as to whether the book has been banned," as you state in your email to Ann Lee dated 29 Jan 2016.

The book was banned. See the BAILIT website for March 2013 — when I was unlawfully imprisoned for alleged Contempt of Court in Postonville Prison for a month, [served 2 weeks.]

I note the phrase "...he is presently in prison and not contactable..." I am, of course, contactable. The "authorities", however, are severely intercepting my post and calls above and beyond the usual interference by "security" in all prisoners' communications.

For your information, the book was banned by Sir Michael Tugendhat (brother of Tugendhat, MP) on 1st Feb 2013.

On 26 March 2013, the Daily Mirror ran a front page headline re "PASSED MPs" (by Tom Pettifer) and on 27 March 2013, (i.e. the next day) I was imprisoned against the rule of law.

The imprisonment was at the behest of Lambeth Council (solicitor PINSENT MASON, barrister CAROLINE ADDY — see her website re her "passion for human rights".)

On 16 July 2013, at the RCJ, Master

Basil Yoxall "shuffled" 5 cases against me — 4 brought by Lambeth and in his shuffling he dropped my meritorious claim for £5m against Lambeth for wrongful dismissal, libel etc. On the same day, Addy — she with the passion for human rights — applied for a PERMANENT GAGGING ORDER against me for the rest of my life.

I note the footnote re the British Legal Deposit Library, which claims it issued a receipt for the book on 16 Feb 2013. Please go to the Freedom of Information website "whatdotheyknow.com" and type in British Library, Brian Peard, F.H.T.L. etc. The Library was reluctant to confirm receipt of FHTL. As you know, the "authorities" (make that MIS et al) like to erase their tracks (to cover their own wrongdoing & make out that the target of their actions is a fantasist or mentally unstable. Thank God for Orwell — who predicted nearly 70 years ago that Governments would continually re-write history in order to erase their own wrongdoing.

I would be grateful to learn of your thought processes re initiating these emails. You might like to contact Pinsent Masons and Caroline Addy, too.

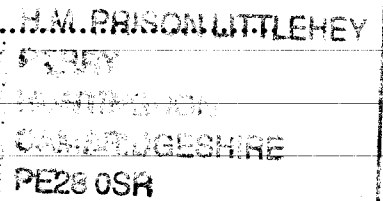

Re: your emails to the R.C.J.

I took possession of a series of
emails alleging to be between you and
the Royal Courts of Justice. I use the
word alleging because the source of
these emails was redacted. (You will
understand my reasonable caution.)

I take the email from "Ann Lee" dated
2 Feb 2016 at face value - at least for
the time being. I note she does not say
that there were "no proceedings" because, of
course, there were. Her answer is a typical
politician's response "...I am not aware."
which, of course, neither confirms nor deny.
Her use of the phrase "I can confirm" is
a favourite rhetorical device used to mislead.
I feel sure you will not have been
misled by such chicanery.
