- 1) Copy of 2012 MG 11 (Sect 9) Witness Statements by Dr Tegwyn Williams and Dr Janis Hillier.
- 2) Copy of 1<sup>st</sup> Dec 11 Judge Llewellyn Jones QC's 14<sup>th</sup> Nov 2011 orders to District Judge Charles.
- 3) Copy of, to date, withheld Caswell Clinic psychiatric reports indentifying my cancer and significant brain damage.
- 4) Copy of Professor Rodger Wood's psychological reports of myself.
