My professional life and credibility was significantly damaged with my patients being concerned about my impartiality and competence, on the basis of Mr KIRK'S statements.

These problems appeared to be of such a nature and degree that continuing to live and work within Wales was practically impossible.

We therefore emigrated leaving behind elderly parents.

Mr KIRK'S statements on his website made gaining employment difficult as Medical Councils would "Google" me before providing registration; and would lead to further questions about my: competence, disciplinary record and correspondence.
