Medical Issues for Bail Appeal and Severity of Sentence

1. In 2014 HMP Swansea denied him pre-arranged hospitals as 'too dangerous' even when released to MAPPA hostel out hourly! Abdominal undiagnosed pain worsened by 8 months more in prison requiring a wheel chair use in such hostile environment.
2. This led HMP again refusing to deliver this Appellant to court, (7th time), for Gilbert J (A20140005 enter HM prison without consent), so that case is now European Court of Human Rights simply because a Cardiff prison (SWP) had refused release of his passport needed for legal papers in France, despite prison release from court acquittal.
3. Those further 8 months without access to a parole board or law court caused the subsequent damages claim against SWP, Ministry of Justice & Parole Board all refusing a hearing or disclose the evidence as to why their victim had been re-called, appeal A2/2017/2747& Warbuoys black cab challenge/parole board failed disclosure
4. Upon final release this Appellant travelled to Jersey to access a private doctor and biopsies via endoscopies to diagnose an advanced case of Barrett's syndrome.
5. In HMP Park MAPPA denied a pre-arranged hospital check-up nor for a private one in the hope the potentially carcinogenic lesions will finally prevent the substantive 1CF03361 machine-gun conspiracy ever needing to go public.
