THAT A COURT PROCEDURE NARROWLY PAIKED TO SET

IN NOT JUST THE POLICE-BUT CARDIFF'S JUDICIARY ALSO

TONIGHT AFTER 9 YEARS IN TRYING, THE PRISON HAD
