3. DRUG ABUSE IS LIKE UNDETERMINING NINE DISCIPLINE AND STAFF MORE
4. IN ORDER TO ACCESS DENTAL MANURE I HAVE HAD TO RESORT TO PROMOTION A 'CODE BLUE' INCIDENT IN ORDER TO GET MEDICAL <sup>ADMITTED</sup>
5. MEDICAL CARE IS APPALLING DUE TO 80% OF 'ALLMENS' MAKE-UP IN ORDER TO OBTAIN A HIGH OR PAIN RELIEF MEDICATIONS EVEN IS A PASTISO

8. OVER 3 WEEKS AGO MY ANKLE WAS CRUSHED IN A VERY HEAVY CELL DOOR BY AN ARMY OFFICER THAT HAS RECEIVED NO PAIN PAIN RELIEF FOR PROPER CLINICAL EXAMINATION.
