## SOUTH WALES POLICE COVER-UP.

1. FURTHER TO MY 25<sup>th</sup> SEPT, 12, 14 & 15 OCT 18 LETTERS RE CONSPIRACY TO CONCOCT A 19<sup>th</sup> OCT 2009 PSYCHIATRIC REPORT, NOT JUST BY DR TEGWYN WILLIAMS BUT <sup>31?</sup> ~~BY~~ <sup>BY</sup> MANY TRYING TO COVER-UP THE POLICE IN BLACKMAIL THIS FORENSIC PSYCHIATRIST TO CONCOCT A MEDICAL REPORT FOR MY ASPHOEN, INCARCERATION INDEFINITELY.
2. 'MANY', INCLUDING A DR ROGER THOMAS NAMED BY NIAS STAFF AS CASWELL CLINIC PSYCHIATRIST ADVISING MY 28 DAY <sup>30<sup>th</sup></sup> RETAIL TO PRISON ON 11<sup>th</sup> JULY, WHILE BOTH MAPPA & ORSHANSEA PRISON WERE ABLE TO DISCLOSE ANY EVIDENCE TO THE PAROLE BOARD OR MYSELF WHY.
3. THIS OCT 2018 G4S DISCLOSURE OF MY 258 PAGES OF MY HOME PARK MEDICAL RECORDS DISCLOSES DR ROGER THOMAS, NOT JUST HAS IN CHARGE OF ANY LOCAL GAINING OF DATA FOR THE PAROLE BOARD, TO REVEAL HIS INFORMATION TO THE BOARD, FOR MY RELEASE OR NOT, CAUSED NO '28 DAY' STAFF ONLY CONVENIENT FOR DELIBERATION AS, I AM RECORD DISCLOSED, AT THE TIME, WAS BECAUSE 'NO PSYCHIATRIST IN THE UK COULD BE FOUND' TO SIT ON IT!
4. PAGE 32 (16<sup>th</sup> JULY 2014) RECORDS DR RUTH BAUSMAN OF 2009 CASWELL CLINIC WAS ABLE TO RELEASE 10 DOCTORS' WRITTEN OPINIONS FOR THE PAROLE BOARD'S DELIBERATIONS, IN MY EVENT, AS TO THE S35 OF 1983 MENTAL HEALTH ACT (CARDIFF CROWN COURT ORDER FOR <sup>MY</sup> PSYCHIATRIC ASSESSMENT).
5. THIS INHIBITION HAD, THEREFORE, A TWO FOLD RESULT:

  - ii) REQUIRING A LOPC INVESTIGATION AS TO WHY I HAD, AFTER CASWELL CLINIC RELEASE, DR ROGER THOMAS HAD CAUSED MY ARREST, THAT CPS WAS FORCED TO TELEPHONE ME ABOUT, APOLOGISING WHEN I WAS INVITED IN BUT INSTEAD, CHARGED WITH BREAKING IN TO CASWELL CLINIC!
