DEAR MR CLARKE,

CONTINUING CRIMINAL MEDICAL CONDUCT BY GAS

1. THE DAY, TODAY'S LEVEL OF GAS, ALMOST EXCEEDS THAT OF THE SOUTH WALES POLICE AND AS SERVING SUBJECT, AS WAS EXPECTED.
2. WHEREAS MY HUNGER STRIKE, STARTED WEEKS AGO, WAS DUE TO GAS'S FAILURE TO ARRANGE MY ROUTINE HOSPITAL PROCEDURES, 2017 FOLLOWING MPPA CANCELLING WITH NO GOOD REASON MY 27<sup>th</sup> DEC 2017 AND FAILURE TO PROVIDE MY DAILY MEDICINE, OMEPRAZOLE FOR A BARRIET'S OESOPHAGUS NOW IT HAS CANCELLED, FORTHWITH, MY ALSO NEEDED COLONOSCOPY. I ENCLOSE 12<sup>th</sup> NOV 18 APPLICATION RETURNED AND WITH COMPUTER RECORD OF £160 PRIVATE ENTEROLOGIST FEE REQUIRED, NON AUTHORIZED BY ME, ONLY TO BE COUNTERMANNED BY LETTER STATING I HAVE ALREADY HAD THE ENTEROLOGIST CONSULT.
3. I ENCLOSE 30<sup>th</sup> OCT 18 (COMP) FORM AGAIN COMPLAINING OF GAS NEVER TO PROMOTE OR EXPEDITE COMPLAINTS WHEN SEEING THEY ARE OF SIGNIFICANT MERIT. MY OBVIOUS APPEAL FOLLOWING DENIED AND DIAGRAM FOR ALL 10 MONTHS, EVIDENCE MY LETTERS TO FIVE, AT LEAST, GAS DOCTORS PLEADING FOR CASWELL CLINIC RECORD, SIGNED BY SOUTH WALES POLICE (P40), LYNDIE DAVIES, QUITE UNQUALIFIED REPLY OF 6<sup>th</sup> NOV 2018, RETURNED MY DOCTORS LETTERS UNREAD. FOR WEEKS ALL MY PAPERS HAVE BEEN CONFISCATED.

MY COMPLAINT RE-BVITAL, REFUSING TO SUPPLY APPEAL FORMS OR DIRF FORMS, WAS 31<sup>st</sup> OCT 18 REPLIED TO BY THIS LADY STATING GAS 'HEALTH CARE' CANNOT ACCESS EITHER CARDIFF HOSPITALS, WHERE I HAD PLEADED MY COLONOSCOPY RECORDS OR MY CASWELL CLINIC 2009 MPPA 3/3 PARCELLED MEDICAL REPORTS BY DATAGNYN WILLIAMS THAT I SUFFER 'SIGNIFICANT BRAIN DAMAGE', DANGEROUS.
5. I NEED TO STRESS, TODAY, MY DISCRIMINATION DIRF FORMS FAIL TO LEAVE PARC FOR ME.
6. MY COMPLAINT 467/18 OF 27/10/18 IS ALSO BLOCKED ON THIS URGENT MEDICAL MATTER TO COMPLAINT NO. HC499 IN TURN BLOCKED BY LYNDIE DAVIES. ITS CONTENT? MY NAME & DR SIMON ABDUL WHO ON 6<sup>th</sup> SEP 18 IS MEDICAL RECORDS ASKED FOR THIS (P?)

SIR, TO INDICATE THE LENGTHS TO WHICH SUCH ANY 'AUTHORITY' IN THIS PERVERSE, SOUTH WALES ENVIRONMENT ROUTINELY BEHAVE LIKE MY 14<sup>th</sup> DEC 2017 SENTANCING JUDGE UTTERING TO DOUBLE AN ALREADY EXCESSIVE ONE YEAR PRISON TERM (COMPLETELY IGNORED BY RS3), TO SAY SHE HAD 'NO POWER' TO CAUSE GMC INQUIRY OR POLICE INVESTIGATION OF MOST DAMAGING ERRONEOUS CARNEL 19<sup>th</sup> OCT 09 MEDICAL REPORT MADE UNDER BLACKHILL I REFER TO MY PLEINORA, ALL YEAR VINDICATED NIAS (WALES) LETTERS 18<sup>th</sup> OCT 18 (PERSON ENCLOSED)
